A graduate from any field who aims to enhance their skills and pursue a career in healthcare financing.

FEE

Program Fee: Rs. 1,00,000 + GST (To be paid in two installments of Rs. 50000 + GST).



Candidates interested in applying for the course require to fill in, the duly filled application, which is available as hard copy from the institute. The duly application form should be accompanied by a cheque or demand draft of Rs. 1000/- drawn in favor of "International Institute of Health Management Research", payable at New Delhi.

PROJECT WORK

The Project work will be allocated in the 6th month and project evaluation(viva) will be in August 2025. The project allocation will mainly focus on candidates work area. Each participant will be assigned Mentor from IIHMR.

PEDAGOGY AND LEARNING SCHEDULE

Each module will be span four weeks and will consist of online lectures, case studies, group work, self-assessment, assignments, quizzes, journal clubs and video presentations. Additionally, there will be a one-week contact program at IIHMR Delhi. The term-end examination will be conducted offline at IIHMR Delhi. Credits for each module will be allocated according to AICTE norms. The online classes will be held as follows: Twice a week (Wednesday from 2 pm - 5 pm & 1st and 3rd Saturday from 10 am- 4 pm). Recorded sessions will be made available after the on-line sessions.

EVALUATION SYSTEM

The faculty will be evaluating participants based on attendance, assignments, class participation and term-end examination.

RESOURCE PERSON

Experts from industry, visiting and internal faculty of IIHMR, Delhi will be involved in teaching /guiding the candidates.

ATTENDANCE

75% attendance is necessary to appear for examination in respective modules.

CERTIFICATE

The candidate must complete the course within two years. The successful candidates will be given certificate by IIHMR Delhi.
